Sue Carpenter - Director of 'I am Belmaya"

Sue Carpenter has been involved in Nepal and women's rights for 20 years. A journalist and photographer, she moved into filmmaking in 2013. Sue co-founded Asha Nepal, an NGO supporting trafficked women in Nepal, and in 2006-2007 lived in Pokhara, running the My World, My View photo project, where she met Belmaya. I Am Belmaya is her first feature-length film and has been selected for numerous international film festivals.

Martin Shearman - British Ambassador to Belgium

Martin Shearman was appointed Her Majesty's Ambassador to the Kingdom of Belgium in June 2019. Martin was previously posted to New York where he was responsible for the UK's engagement with the United Nations on development, humanitarian and human rights issues. He also led the Department of Trade and Industry's Japan Unit and worked at the Cabinet Office on a major review of HM Government's trade promotion structures.

16 Days of Activism

On 25th of November, the 16 Days of Activism against violence against women and girls (VAWG) kicked off, which lasts until 10 December, Human Rights Day.

In 2021, COVID-19 has exacerbated all the risk factors for VAWG, including unemployment and poverty, and reinforced many of the root causes such as gender stereotypes and harmful social norms, causing a shadow pandemic of gender-based violence. In addition to the impact of COVID-19, the global context of violent conflicts and humanitarian crises, including climate-related disasters, are affecting more people than ever before, with a disproportionate impact on women and girls, perpetuating all forms of VAWG.

This year's global campaign theme will focuses on all forms of violence with the theme "Orange the World: END VIOLENCE AGAINST WOMEN NOW!", to advocate and amplify the call to end violence against women and girls!

Gender equality is at the heart of UK foreign policy and one of the top priorities for the Foreign Secretary. Our focus in on empowering more women and girls with the opportunity offered by quality education and employment, and ending the violence they suffer. We are committed to step up our work with women-led civil society to design solutions to advance gender equality and tackle violence against women and girls. We are determined to strengthen the international response to sexual violence in conflict, shattering the culture of impunity around the use of rape and sexual violence as weapons of war. We are exploring all options for further international action, including the possibility of a new international convention and have committed more than $\pounds 20$ million of new funding to help stop violence against women and girls around the world. We have also just launched our new flagship What Works to Prevent Violence: Impact at Scale Programme, which is investing $\pounds 67.5$ million in scaling up proven approaches to prevent violence against women and girls worldwide.
