Failure to recycle many metals around the world not only causes wasted resources and environmental damage, it threatens shortages of elements essential to modern technologies, according to the first-ever comprehensive analysis of the problem. "In spite of significant efforts in a number of countries and regions, many metal recycling rates are discouragingly low, and a 'recycling society' appears no more than a distant hope," the United Nations Environment Program (UNEP) states in a new report, the first attempt to gather accurate and consistent information about the extent to which metals are collected, processed and reused in new products. The weak performance is especially frustrating because, unlike most other resources, metals are "inherently recyclable," says the study compiled by the UNEP-hosted International Resource Panel.

The first-ever "World report on disability" provides the first global estimates of persons with disabilities in 40 years and an overview of the status of disability in the world. New research shows that almost one-fifth of the estimated global total of persons living with disabilities, or between 110-190 million, encounter significant difficulties. The report stresses that few countries have adequate mechanisms in place to respond to the needs of people with disabilities. Barriers include stigma and discrimination, lack of adequate health care and rehabilitation services; and inaccessible transport, buildings and information and communication technologies. As a result, people with disabilities experience poorer health, lower educational achievements, fewer economic opportunities and higher rates of poverty than people without disabilities.

The UN General Assembly will hold a one day high-level meeting in New York on 22 September 2011, to commemorate the 10th anniversary of the adoption of the Durban Declaration and Programme of Action, the international community's blueprint for action to fight racism. A one-day event at the level of Heads of State and Government, the meeting will take the form of a plenary session and a series of round table discussions.

Guiding Principles on Business and Human Rights: Implementing the United Nations "Protect, Respect and Remedy" Framework

The United Nations Human Rights Council has endorsed a new set of Guiding Principles for Business and Human Rights designed to provide -for the first time- a global standard for preventing and addressing the risk of adverse impacts on human rights linked to business activity. The Guiding Principles are the product of six years of research led by Professor Ruggie from Harvard University, involving governments, companies, business associations, civil society, affected individuals and groups, investors and others around the world. They are based on 47 consultations and site visits in more than 20 countries; an online consultation that attracted thousands of visitors from 120 countries; and voluminous research and submissions from experts from all over the world.

The Special Procedures of the Human Rights Council are independent human rights experts with mandates to report and advise on human rights from a thematic or country specific perspective. The system of Special Procedures is a central element of the United Nations human rights machinery and covers all sets of rights: civil, cultural, economic, political, and social. As of May 2011, there are 42 Special Procedures (33 thematic mandates and nine mandates relating to countries or territories) with currently 60 mandate-holders.

The feature describes the enormous contribution the Tribunal made to the prosecution and adjudication of crimes of this nature.

Following the lead of its sister tribunal for Rwanda, the Tribunal was among the first courts of its kind to bring explicit charges of wartime sexual violence, and to define gender crimes such as rape and sexual enslavement under customary law.
