Contact Group on Piracy off the Coast of Somalia – official website

The Contact Group, or CGPCS, established 14 January 2009 pursuant to United Nations Security Council resolution 1851 (2008), is a voluntary, ad hoc international forum of approximately 70 countries, organizations and industry groups with a common interest in combating piracy in the Gulf of Aden and the Indian Ocean, and bringing to justice pirates and their financiers and facilitators. As the Contact Group does not have a standing secretariat, the Republic of Korea suggested the establishment of an official website during the 7th plenary session held in November 2010. The Contact Group website will serve as a cyber secretariat offering a sphere of communication for Contact Group participants; a database storing Contact Group documents and other piracy-related materials; and an information centre promoting the work of the Contact Group to the general public. The website will be jointly operated by the Republic of Korea, the United Kingdom and the United States (Press release SC/10401-AFR/2257, 4 October 2011).

"The Global Reported Arms Trade" – new web platform

The UN Office for Disarmament Affairs launched on 18 October a ground-breaking web feature that provides increased transparency in the global arms trade. This web platform will make tracing the transfer of all arms imports and exports recorded in the UN Register of Conventional Arms user-friendly by presenting data in a searchable, easily accessible manner, providing a wealth of previously difficult-to-find information. This tool can be a valuable asset to an array of UN and Member State users, including Security Council arms embargo monitoring panels, which will be able to locate weaponry that was originally reported by the exporter. Information on military expenditures can also be collected. Anyone working on the nexus between security and development, security sector reform and transparency and corruption will benefit from this tool.

2011 Afghan Opium Survey: Summary findings (UNODC)

Opium poppy-crop cultivation in Afghanistan reached 131,000 hectares in 2011, 7 per cent higher than in 2010, due to insecurity and high prices. Afghanistan suffers from one of the highest rates of opiate consumption in the world with a current prevalence rate of 2.65 per cent. In 2005, the prevalence rate of opiate use was 1.4 per cent. The country also faces an HIV epidemic among the country's injecting drug

The UN Office on Drugs and Crime (UNODC) has released its first Global Study on Homicide, which shows that young men, particularly in Central and South America, the Caribbean and Central and Southern Africa, are at greatest risk of falling victim to intentional homicide but that women are at greatest risk of murder owing to domestic violence. There is evidence of rising homicide rates in Central America and the Caribbean, which are "near crisis point", according to the Study.

According to the report, national schemes, such as pensions, safety nets and school feeding programmes, can impact positively on several MDGs by addressing the immediate needs of the most vulnerable, providing them with labour market skills and safeguards against relapses into poverty.

The Report shows that the potential of leveraging information and communication technologies (ICTs) to develop the private sector is far from fully exploited. It finds that many national and donor strategies related to PSD currently fail to take adequate account of the ICT potential, which has greatly expanded thanks to changes in the global ICT landscape. The Report then makes policy recommendations on how to remedy this situation.

While some large countries were able to deal with the worst of the crisis, people in many small import-dependent countries experienced large price increases that, even when only temporary, can have permanent effects on their future earnings capacity and ability to escape poverty.

Children's access to justice in conflict and post conflict situations is the focus of this UN publication launched in September 2011 during the session of the UN Human Rights Council. Produced by the office of the UN Special Representative of the Secretary-General for Children and Armed Conflict, Radhika Coomaraswamy, the working paper examines how children who have suffered grave violations during armed conflict can access justice and how the current system deals with child victims and witnesses. It also explores the responsibility of children who were associated with armed forces and have committed violations during armed conflicts.

On 18 December 2009, the United Nations General Assembly proclaimed the year beginning on 1 January 2011 the International Year for People of African Descent. The Year aims at strengthening national action and regional and international cooperation for the benefit of people of African descent.

An electronic toolkit was designed by the Office of the United Nations High Commissioner for Human Rights (OHCHR) in order to assist its staff around the world tackle issues related to the situation of people of African descent, during the International Year and beyond.

Treatment of Conflict-Related Detainees in Afghan Custody (UNAMA)

A new United Nations report released on 10 October 2011 cites evidence of the "systematic" torture and mistreatment of detainees in Afghan detention facilities, including of children, and provides recommendations which it hopes will spur the necessary reforms. The report by the UN Assistance Mission in Afghanistan (UNAMA) is the result of extensive interviews from October 2010 to August 2011 of 379 pre-trial detainees and convicted prisoners at 47 facilities of the National Directorate of Security (NDS) and Afghan National Police (ANP) in 22 provinces.

UNODC Human Trafficking Case Law Database

The UN Office on Drugs and Crime (UNODC) has developed a human trafficking case law database to provide immediate, public access to officially documented instances of this crime. The database contains details on victims' and perpetrators' nationalities, trafficking routes, verdicts and other information related to prosecuted cases from across the world. In doing so, it provides not only mere statistics on numbers of prosecutions and convictions, but also the real-life stories of trafficked persons as documented by the courts. The database aims to assist judges, prosecutors, policy-makers, media researchers and other interested parties by making available details of real cases with examples of how the respective national laws in place can be used to prosecute human trafficking. At its launch, more than 150 selected cases from over 30 countries and two regional courts have been uploaded, with an additional 100 cases from over a dozen states to be added in the coming months.

Industrialized countries saw a 17 per cent increase in asylum applications in the first half of this year. The report shows that 198,300 asylum applications were lodged in the period between January 1 and June 30, compared to 169,300 in the same period in 2010.
