## Kenneth Michiels



Kenneth Michiels grew up in Sint-Genesius-Rode. He studied Film at the Royal Academy of Fine Arts (KASK) in Ghent and obtained his master's degree with Great Distinction. Kenneth finished 'L'Etranger' in 2016. Concerning the subjects of his documentaries, Kenneth tends to call upon stories that are linked to his own habitat, but that are simultaneously taboo to bystanders. He also works as a video artist for theatre house Kopergietery and as a freelancer for VRT and CANVAS. In 2012 he established his own Production House Moose & Tash, in cooperation with some like-minded people. At the moment Kenneth works on a new documentary that will be released in summer 2018.

## Moussa Cissokho



Moussa Cissokho was only 14 years old when he lost his father, but nevertheless managed to work his way up and became a self-employed plumber. At the same time, he became active in his "quartier", teaching kids the most elementary rules of both football and life. In 2014, Moussa married Barbara, a Belgian woman, and they moved to Belgium. During his first year, he struggled to find a job but was able to start as the coach of the U14-team of BX Brussels. Then he found a job as a handyman, celebrated the birth of their first son and therefore had to give up his coaching at BX. However, he still plays friendly games on a weekly basis and is a loyal supporter of Club Brugge - football still dominates his life.

## Ingrid Pelssers



Mrs Ingrid Pelssers works as an *Advisor International Affairs* at the Government of Flanders. She analyses international policies on the topics of Equal Opportunities and Integration in order to stimulate innovations in Flanders and Brussels. In her previous position as Emancipation Officer she was responsible for promoting diversity in the workforce of the Flemish Public Service. She has a Master's degree in Political Sciences (KU Leuven) and a Master's degree in Public Management (Antwerp Management School).

## Gijs leven



As Community Coordinator Gijs leven controls the working of the community of BX Brussels. The community team covers the individual supervision of both the players and the parents and organizes activities aimed at parents, players and trainers to strengthen the community. Therefore, they constantly engage in a dialogue with other relevant stakeholders in the city, like for instance SOS Kinderdorpen, AB Concerts and the KVS. In the past, Gijs worked as senior staff member at De Ambrassade, a center for knowledge and expertise with respect to youth work and youth policy in Flanders.

**TOGETHER - Respect, Safety and Dignity for All**

**What is TOGETHER?**

TOGETHER is a global campaign that aims to change negative perceptions and attitudes towards refugees and migrants, and to strengthen the social contract between host countries and communities, and refugees and migrants.

All 193 Member States of the United Nations unanimously welcomed the TOGETHER campaign and committed to implementing it, when they met at the Summit for Refugees and Migrants on 19 September 2016. TOGETHER will run until 2018, when Member States are expected to adopt two Global Compacts on Refugees and Migrants.

The **Flanders Department of Foreign Affairs** is in charge of all of the Government international relations. It coordinates Flanders’ international and European activities and therefore takes the lead in Flanders’ relations with foreign governments, the European Union and international organizations. This includes the transposition of European legislation and the conclusion and ratification of international treaties. Amongst many tasks, the department is responsible for

Flanders’ development cooperation, with a geographical focus on Southern Africa and monitoring import, export and transfer of weapons and strategic goods from Flanders.



To execute these tasks, the Department has a budget of around 46 million euros and it relies on the enthusiasm and dedication of a hundred staff members at its head office in Brussels and eleven General Representations of the Government of Flanders, accredited to a number of well-chosen countries (The Hague, Berlin, Paris, London, Madrid, Warsaw, Vienna, New York, Pretoria and Geneva) and international organizations (Council of Europe, EU, OECD and UN).
