DIRECTORS' NOTES

With our documentary we want to stimulate a debate that is long overdue: Almost 15 years after their invention, social networks have come to be both a powerful and dangerous tool that is capable of dividing societies, excluding minorities and promoting genocide. We want to bring into focus where our societies are heading, if we leave the responsibility for the digital public sphere to private companies that turn outrage and collective uproar into money and despite all lip service don't take genuine efforts against these developments. We want to show that it's no coincidence that the political developments worldwide facilitate the elimination and exclusion of everything that "disturbs," rather than deal with the underlying problems. This ideology is gaining consent all around the globe, analog and digital, and it's our duty to stop it before it's too late. We can't longer afford the convenience to outsource every form of responsibility. The question of democracy and freedom of speech must not only have the two options:

Delete or ignore.
